# Local Business Owners Survey

**Report of Results** 

August 8, 2018



### **Executive Summary**

The City of Sisters conducted its second local business owner survey between the months of May and July in 2018. The survey was included with all of the business license renewal applications and therefore all businesses, whether in the city or not, were given the opportunity to have input on a series of questions regarding city services.

A total of 530 surveys were mailed in the third week of May. There were 358 in-city businesses and 172 out-of-city businesses included in the mailing. Return rates at the end of July stood at 147 completed surveys of which 120 were in-city businesses and 27 out-of-city businesses. Percentage wise the total response rate was 27.7% (in-city 33.5% and out-of-city 15.7%).

Using a 95% confidence interval the margin-of-error for the survey is approximately six percent (6%). In other words we can be confident that the survey responses accurately reflect the opinion of the entire population (local business owners) 95% of the time with a margin of error of plus or minus six percent (6%) around each data point.


Although I had hoped for a slightly higher return rate, it should be noted that over one-third of in-city businesses responded to the survey which is an above-average response rate to a mailed survey. The following sections contain the highlights of the results of the survey as well as various appendices with summaries of written responses.

## Results

#### Public Services and Infrastructure


The survey asked seven questions regarding public services and infrastructure that most likely impact business owners. Generally speaking the city performed well in almost all most areas. The results indicate that our downtown is a very desirable place to open a business and that the streetscape and parks are most highly regarded.

Respondents were very satisfied with overall public services provided by the City. 86% rated services as excellent or very good.



Among specific services, streetscape amenities in the downtown, and maintenance of streets and parks ranked the highest with 95% and 93% excellent or very good ratings respectively. The lowest rated areas were available parking in the downtown and city information kiosks showing businesses and services. A total of 44% and 51% rated these services as excellent or very good.

Finally, the responsiveness of city staff was also rated very highly, with 84% saying staff is either excellent or very good. How businesses view City Hall is critical from a customer service standpoint and I believe staff should be commended for the overwhelmingly positive feedback.



## Affordable Housing

As we know, housing affordability is a problem that faces almost all communities in Oregon and Sisters is no different. Specific to the business survey we asked if housing affordability affected the ability to hire and retain employees. Of the respondents, 42% stated that it did have an impact, while 58% stated that it did not. Obviously this data illustrates that housing affordability is not a concern for the majority of businesses surveyed, however the fact that over 40% of our businesses are negatively impacted by housing should give one pause. The City should continue to look for ways to address affordable housing through a program of robust public and private solutions.


#### Plastic Bag Ban

This question was included as a follow up to a presentation by a group of high school students concerned with the impacts of plastic on our environment. Although many businesses in Sisters already do not offer plastic bags, likewise many do. A variety of concerns ranging from cost, convenience and consumer preference were discussed as a part of any proposal to ban plastic bags. That being said, more and more studies prove that plastics are having a very negative impact on our planet, wildlife and humans.

Based on the results of the survey, there is clear support among business owners to ban plastic bags with 60% either strongly supporting or supporting a ban on the use of this type of bag. On the other side, 21% strongly oppose or oppose any ban. 18% responded they neither support nor oppose such a ban.

#### Transient Merchants on Cascade

As you know, per municipal code, chapter 5.35.020.03 transient merchants are not allowed within 100' of Cascade Avenue. The question of whether to review the ordinance or not, perhaps more than any other, shows the most diversity in responses. As you can see from the chart below an equal number of respondents support and oppose reviewing the setback requirement. Even more interesting is the fact that a plurality of respondents don't seem to be concerned either way. It is important to note that our survey does not distinguish whether a respondent's business is on Cascade or not. Because these businesses would be the most impacted by any changes it is probably important to individually poll them before considering any modifications in the ordinance.



#### Business Development and Job Creation

As we know, economic development is one of the greatest challenges facing small towns. As we struggle to attract businesses that pay livable wages and bring families into our communities it is critical to understand whether businesses feel the city is doing its part to support economic development. The results of the survey indicate that the vast majority of the respondents believe that the city is appropriately focused on new business development and job creation. 76% of the surveys indicated that we are doing enough while only 24% indicated we should be doing more. An important caveat to point out is that almost half of the survey respondents did not answer this question or indicated that they did not know how to answer the question. This fact probably illustrates that many businesses simply do not know what work is being done with economic development and that the city, Chamber of Commerce and EDCO might want to collaboratively educate business owners on our economic development program.

## Conclusion

The Local Business Survey results indicate that businesses are generally very satisfied with the services they receive from the city. Although parking in the downtown is perceived as more problematic than other areas, it should be pointed out that this is consistent with the results of most downtown areas throughout the country. The city may want to consider doing a parking study in the future to determine whether or not there is indeed a problem.

There seems to be solid support for banning plastic bags in the City while reaction is mixed to making changes to the transient merchant setback on Cascade. Additionally the survey revealed that there is little support for the city to take over snow removal in public parking lots and sidewalks in the downtown.

Finally, a vast majority of the businesses believe the City is properly focused on economic development, however more should be done to make businesses aware of the programs available to them.
