Deschutes County Forgivable Loan Program

The Deschutes County Forgivable Loan Program provides funds for buildings and/or equipment to eligible businesses* that will be creating at least five full-time equivalent jobs within two years. FINDING YOUR LOCATION

City of Sisters Land Use Regulations

The City of Sisters has codes that regulate where and how certain types of businesses can be permitted within city limits. For any new business looking to locate in Sisters, Oregon, the Sisters Community Development Department is your best resource in identifying which zoning district and/or property would be suitable for your needs and determining if any land use review, permits, licenses and fees will be required. *Before you secure a location for your business*, contact a City Planner or research the City codes: https://www.codepublishing.com/OR/Sisters/

Deschutes County Building Division for Building Renovations

Once you know that the business is an allowed use per the City codes and you have identified a building location, contact Deschutes County to determine if building permits are required before you secure a lease for the building.

Sign Permits

With any new business, it is likely that new signage will be needed. All new or remodeled signs within city limits require a sign permit. Examples: walls signs, window signs, change of copy, temporary banners, sandwich boards.

Prior to operating, the City of Sisters requires an annual business license for businesses operating and/or doing work within the city limits.
