Request: Minor Partition of two lots into three parcels of land. Parcel #1 will result in 65,506 SF of area, Parcel #2 will result in 60,740 SF of area, and Parcel #3 will result in 121,150 SF of area.
Applicable Criteria: Sisters Development Code (SDC) – Chapter 4.1 (Applications and Procedures); Chapter 2.3 (Multi-Family Residential); Chapter 4.3 (Land Divisions).

Questions or concerns regarding this application should be directed to the Community Development Department at Sisters City Hall. The decision issued will be administrative, and will occur according to Development Code Chapter 4.1 Procedures, which is available at City Hall. Failure to raise an issue in person, or by letter before or during the issuance of the decision, or failure to provide statements or evidence sufficient to afford the decision-maker an opportunity to respond to the issue, may preclude an appeal based on that issue with the



State Land Use Board of Appeals. All evidence relied upon by staff to make this decision is in the public record and is available for public review at the Sisters City Hall, 520 E. Cascade Avenue, Sisters, Oregon. Copies of this evidence can be obtained at a reasonable cost from the City. After the comment period closes, the Community Development Director or designee shall issue a Type II Administrative Decision. The decision shall be mailed to the applicant and to anyone else who submitted written comments or who is otherwise legally entitled to notice.
