- 2. Permittee shall not use this permit nor the property which is the subject of this permit for any other use than described in the above explanation.
- 3. The permit may be revoked by the City of Sisters with a minimum ten-day notice.
- 4. Please provide <u>verification of liability insurance</u>, or its equivalent, with a certificate of insurance coverage available from your insurance agent. If the certificate of insurance is not provided within ten days, this permit will be revoked.
- 5. 48 inches of clear passage width must be maintained on City sidewalks to meet Americans with Disability Act (ADA) requirements. Other disability access requirements for public and private entities can be found at the following link: <u>About the Rulemaking on Public Rights-of-Way</u> (See Proposed Guidelines 2011).
- 6. Upon request of the City, Permittee shall remove whatever improvements or use of the property which is the subject of this permit and shall restore the property to either the original condition before the permit was issued or provide whatever other removal or restoration as directed by the City.
- 7. Nothing contained in this permit nor in Permittee's use of the property which is the subject of the permit shall in any way give Permittee any rights or privileges superior to the City of Sisters.
- 8. This revocable permit shall be binding upon the heirs, successors, personal representatives and assigns of the owner of the parcel or land described above, and shall constitute a covenant running with the land.
- 9. Permittee shall comply with all the rules, regulations or directions issued by the City during the period of this permit.
