## An Important Message from the Environmental Protection Agency Required information by EPA

The sources of (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals and human activity.

**Microbial contaminants**, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

**Inorganic contaminants**, such as salts and metals, which can be naturally-occurring or result from urban storm-water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and Herbicides, comes from agricultural, urban storm-water runoff, and residential uses.

**Organic Chemical Contaminants**, synthetic and volatile organic chemicals are byproducts of industrial processes and petroleum production, and also from gas stations, urban storm-water runoff, and septic systems.

Radioactive Contaminants, Naturally occurring or the result of oil and gas production and mining activities.

Drinking water and bottled water may contain at least small amounts of some contaminants. # Lead in Drinking Water....*Are You at Risk?*

Elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Sisters is responsible for providing high quality drinking water to your tap. We cannot control the variety of materials used in plumbing components in your home. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water to drink or for cooking. If you are concerned about lead in your water, you can have your water tested. # **Important Information About Water and Your Health**

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/Aids or other immune system disorders, some elderly, and infants can be particularly at risk for infections. These people should seek advise about drinking water from their health care providers. Detected Regulated and Unregulated contaminants are listed below. Unregulated Contaminants are those for which the EPA has not established drinking water standards. The purpose of unregulated contaminant monitoring is to help the EPA determine their occurrence in drinking water and potential need for future regulation. the City of Sisters did not receive any violations for its water system.

The City Of Sisters chlorinates well #1 with a chlorine gas and wells 2 & 3 with an on site generated sodium hypochlorite to ensure that the water you are drinking is free of any microbial contaminants from the source to your tap.

#### **KEY & DEFINITIONS**

- AL Action Level, the concentration of a contaminant which if exceeded, triggers treatment or other requirements.
- EPA Environmental Protection Agency, sets water quality standards and establishes methods and monitoring requirements for water utilities.
- MCL Maximum Contaminant Level, the highest level of a contaminant that is allowed in drinking water. MCL's are set as close to the MCLG's as feasible using the best available treatment technology.
- MCLG Maximum Contaminant Level Goal, the level of a contaminant in drinking water which there is no known or expected risk to health. MCLG's allow a margin of safety.
- PPB Parts Per Billion. the equivalent of one second in 32 years.
- PPM Parts Per Million, the equivalent of one second in 12 days.
- pCi/I Picocuries Per Liter, a measure of radioactivity



# **City of Sisters Source Assessment**

The 1996 amendments to the Safe Drinking Water Act require that all states conduct Source Water Assessments for public water systems within their boundaries. The assessments consist of (1) identification of the Drinking Water Protection area, i.e., the area at the surface that is directly above the part of the aquifer that supplies groundwater to our well. (2) identification of **potential** sources of pollution within the drinking water protection area, and (3) determining the susceptibility or relative risk to the well water from those sources. The purpose of the assessment is to provide water systems with information they need to develop a strategy to protect our groundwater resource.

The Drinking Water Programs of The Department of Human Services and Environmental Quality have completed a Source Water Assessment. A copy of the report is available for viewing by contacting our office at (541) 549-6022.
